2. Certain age, height and weight restrictions apply to a number of activities. These are listed below:

- No persons under the age of 10 may participate in any activity. Karting Minimum inside leg measurement of 26 inches is required for Karting participation.
- Participant minimum ages Karting Racing 16 years, Off Road Buggies and Powerturns participants must over 17 years old and less than 65 years old and have a chest size less than 48 inches.

- Quad Bike Trekking participants must be reasonably fit and over 12 years old and of a suitable size to safely participate.
- Junior Quad Bike Participants must be under the age of 14 years old
- Off Road Buggy participants must be at least 5ft tall.
- Archery participants must be over the age of 14 years old.
